Section 4. First aid measures

roll, slide, or drop. Use a suitable hand truck for cylinder movement.

should be stored upright, with valve protection cap in place, and firmly secured to prevent falling or being knocked over. Cylinder temperatures should not exceed 52 °C

(125 °F).
