SECTION 6: ACCIDENTAL RELEASE MEASURES

Accidental Release Measures: Refer to other sections of this MSDS for information regarding physical and health hazards, respiratory protection, ventilation, and personal protective equipment. Call 3M-HELPS line (1-800-364-3577) for more information on handling and managing the spill. Remove all ignition sources such as flames, smoking materials, and electrical spark sources. 7.1 HANDLING

This product is not intended to be used without prior dilution as specified on the product label. Avoid eye contact with vapors, mists, or spray. Avoid skin contact.
